**PART I: NOTICE TO BIDDERS**

The City of Sedalia Parks & Recreation Department will receive proposals for Pool Chemicals. Specifications are available in Part III.

Only proposal forms provided by the Parks and Recreation Department shall be used.

All such proposals as provided for herein shall be sealed and mailed/delivered to the Sedalia Parks & Recreation Department, 1800 W. 3<sup>rd</sup> St., Sedalia, MO 65301, at or prior to 11 a.m. on Monday, December 9, 2024. Proposals will be opened at or shortly after the above date & time.

Any proposal received after the above stated date will be returned unopened.

The City of Sedalia Parks Department retains the right to reject any and all proposals submitted, and to waive any informality contained in any proposal. The Sedalia Parks Department reserves the right to accept the proposal deemed most advantageous to the Sedalia Parks and Recreation Department.

**PART II: INFORMATION TO BIDDERS**

**A. BID ACCEPTANCE**

The City of Sedalia Parks & Recreation Department (SPR) reserves the right to accept or reject any and all bids, to accept any bids deemed advantageous, and to waive irregularity in the bids. By bidding, the bidder acknowledges and will adhere to all bid specifications as stated within this bid packet. Only the services submitted and listed in this bid package and included in any addendums will be considered.

**B. BID DEADLINE, FORMAT, AND SUBMISSION**

1. All such proposals as provided for herein shall be sealed and mailed/delivered to the Sedalia Parks & Recreation Department, 1800 W. 3<sup>rd</sup> St., Sedalia, MO 65301, at or prior to 11:00 a.m. on Monday, December 9, 2024.
2. Only proposal forms provided by the Parks and Recreation Department shall be used. Your submission should include all pages within this bid packet (pages 1-7)
3. **Mark on outside of outer-most envelope or mailer "BID ON POOL CHEMICALS."**

**C. BID OPENING**

4. Proposals will be opened at or shortly after 11:00 a.m. on Monday, December 9, 2024.

**D. BID AWARD**

It is the intention of SPR is to award this bid to the lowest reasonable and responsible bidder. **The initial term will be two (2) years, with the option to renew for (2) additional one-year periods with no more than a 5% escalation per renewal term**, available upon the mutual agreement of the parties. SPR reserves the right to make a single award or multiple awards, whichever is in the best interest of SPR to accomplish all services outlined in this bid.

Anticipated contract start is February 1, 2025.

**PART III: SPECIFICATIONS FOR POOL CHEMICALS**

**A. INTRODUCTION**

1. SPR seeks competitive bid for supply and delivery of Pool Chemicals. The purpose of these specifications is to describe the minimum requirements of SPR for the goods and services described. The quantities listed are estimates based on previous usage. These estimates are for acquainting the bidder with probable quantities to be expected during the contract period. These estimates are not intended to set forth minimum or maximum quantities of this contract and shall not be construed as such.
2. SPR has two locations to which chemicals will need to be delivered to: Heckart Community Center at 1800 W. 3<sup>rd</sup> St. Sedalia MO and Liberty Pool at 1700 W. 3<sup>rd</sup> St. Sedalia MO.
3. SPR must be supplied MSDS sheets for all chemicals.

**B. QUANTITY**

The quantities listed below are estimated needs for 1 year.

**Versachlor Chlorine Tablet**

**(Cannot be any other type of chlorine tablet due to existing equipment)**

Delivery to Heckart Community Center

Needed year round

Estimated annual need: 192 buckets

**Acid-Rite**

**(Cannot be substituted due to existing equipment)**

Delivery to Heckart Community Center

Needed year round

Estimated annual need: 108 buckets

**Sodium Bicarbonate**

Delivery to Liberty Pool  
Needed seasonally (approx. May-September)  
Estimated need: 300 fifty-pound bags

**Sulfuric Acid 40%**

Delivery to Liberty Pool (storage tank)  
Needed seasonally (approx. May-September)  
Estimated need: 2600 gallons

**Vertex Concentrate 10%**

Delivery to Liberty Pool  
Needed seasonally (approx. May-September)  
Estimated need: 3100 gallons

**Carbon dioxide liquid**

If available within Sedalia, SPR will pick up.  
Needed year round  
Estimated annual need: Forty four (44) 528 lb. cylinders; and seven (7) 50 lb. cylinders.

The quantities listed above are estimates and do not guarantee order quantities over the course of the contract resulting from this bid. SPR reserves the right to increase or decrease these quantities, based upon need by SPR.

**C. ORDER & DELIVERY REQUIREMENTS**

Delivery is an essential part of this contract. If, during the term of the contract, the seller cannot fill delivery requirements, SPR retains the right to terminate the contract and make purchases from an alternate source. Normal deliveries can be made Monday-Friday between 7am and 12 pm noon.

**D. PRICING**

1. Prices for all goods and/or services shall be firm for the initial term of the contract.
2. Prices shall be inclusive and list all the charges as necessary to perform the requirements of this bid.
3. **If there are any additional charges of any kind, other than those mentioned above, specified or unspecified, bidder MUST indicate the terms required and attendant costs or forfeit the right to payment for such terms.**

**E. ACCEPTANCE OF MATERIAL**

Products which are not compliant with the specifications and/or not up to SPR quality standards will be returned and replaced with compliant products at the vendor's expense. Payment will not be made for any non-compliant materials.

**F. VEHICLES/EQUIPMENT**

Transportation of chemicals shall be in compliance with State and Federal transportation handling and safety requirements. Vendor shall, if requested by SPR, produce documentation to demonstrate compliance with such requirements.

**G. SPILL PROCEDURES**

1. The vendor shall be responsible for any spills and/or leaks resulting from delivery or faulty equipment.
2. All incidents must be reported immediately to a SPR representative and the vendor is responsible for appropriate actions to clean up the spill.
3. If the vendor has not begun a clean-up remediation within thirty (30) minutes of the spill, SPR will hire a certified hazardous material handling company and the cost of such service will be charged to the vendor.
4. If the spill is due to SPR's equipment, and not the fault of the vendor, the vendor will be relieved of cleanup and/or charges.

**H. DAMAGE TO PUBLIC PROPERTY**

Extreme care shall be taken to safeguard all existing facilities, site amenities, irrigation systems, vehicles, etc. on or around the job site. Damage to public and/or private property shall be the responsibility of the vendor and shall be repaired and/or replaced at no additional cost to the City.
