Player Code of Conduct

I hereby pledge to be responsible for my words and actions while attending or playing in a sport event sponsored by the Sedalia Parks and Recreation and shall conform my behavior to the following code of conduct:

- 1. I will not engage in unsportsmanlike conduct with any parent, player, participant, official, staff, or any other attendee.
- 2. I will not encourage my child, any other child, or person, to engage in unsportsmanlike conduct with any parent, participant, official, staff, or any other attendee.
- 3. I will place the emotional and physical well-being of my players ahead of a personal desire to win.
- 4. I will treat each player as an individual.
- 5. I will, to the best of my ability, ensure a safe playing situation for everyone.
- 8. I will not engage in any behavior which would endanger the health, safety or well being of any parent, participant, official, staff, or any other attendee.
- 9. I will not encourage my child, any child or any other person, to engage in any behavior which would endanger the health, safety or well-being of any parent, player, participant, official, staff, or any other attendee.
- 11. I will not engage in verbal or physical threats or abuse aimed at any parent, player, participant, official, staff, or any other attendee.
- 12. I will not initiate a fight or scuffle (verbal, physical, or both) with any other player, participant, official, staff, or any other attendee.
- 13. I will conduct myself in a calm, respectful, and professional manner with staff of the Sedalia Parks and Recreation Department.
- 14. I will not engage in the consumption of alcoholic beverages before or during games, or on Parks and Recreation property.
- 15. I will not bring a weapon on premises.
- I acknowledge that I will not be able to participate with Sedalia Parks and Recreation until a signed copy of this Code of Conduct is returned to the Parks & Recreation Supervisor.

Disciplinary Consequences:

I hereby agree that if I fail to conform my conduct to the aforementioned policies while attending or playing in a sports event sponsored by Sedalia Parks and Recreation, I will be subject to disciplinary action, including but not limited to the following in any order or combination:

- 1. Verbal warning issued by the Parks & Recreation Board.
- 2. Written warning issued by the Parks & Recreation Board.
- 3. Immediate ejection from the game by the Parks & Recreation Board.
- 4. Suspension from multiple games issued by the Parks & Recreation Board.
- 5. Season suspension or multiple season suspension issued by the Parks & Recreation Board.
- 6. Debarment from future participation in Parks and Recreation programs.
- 7. Potential legal ramifications.

*Please Note: ANY physical altercation, whether before, during, or after the game while on Sedalia Parks and Recreation property will result in an immediate suspension from the league for the remainder of the season. The team of the offender will only be allowed to replace this team member if an incident occurs before the third game of the season. No exceptions will be made, as the Sedalia Parks and Recreation will maintain a **ZERO-TOLERANCE POLICY** when it comes to fights and/or altercations.
